## **Promotional Rules**

**Function:** Senior Appreciation Day

**Date(s):** Wednesdays in December 2021

**Time(s):** 8:00am to 8:00pm

**Registration:** Open during promotion time frame

Drawing registration: Activate drawing tickets before every drawing, starting at 11:00am on valid drawing dates. Drawing drum closes two (2)

minutes prior to each drawing.

**Criteria:** Open to all Sun Club Members 55 and older

**Participants:** Swipe & Win – Limit one per player

Early Bird Cash Drawings – Players may only win once per day

Offer Details: Early Bird Cash Drawings – All Sun Club Members 55 and older will

receive one (1) drawing entry for every 100 same-day points. Activate tickets at the Sun Club Kiosk. One winner will be drawn every 30 minutes

Noon-4pm.

Swipe & Win Kiosk Game – For all Sun Club Members 55 and older, participate in swipe and win promotion. One free swipe/play every

Wednesday.

# **Rules & Regulations**

## **Eligibility:**

1. Must be a member of the Sun Club age 55 or older.

- 2. Must be 21 years of age or older to obtain a Sun Club Membership.
- 3. No purchase necessary to receive a Sun Club rewards card.
- 4. A valid photo ID is required to verify age and identity.

#### **Implementation:**

- 1. Each Sun Club member 55 years of age and older are eligible to participate.
- 2. Guests are eligible to participate every Wednesday in December.
- 3. All participants must play their own promotion using their own Sun Club Membership Card. No Substitutes or transfers are allowed.
- 4. In case of conflict, a CSM or Marketing Manager or above will follow all gaming regulations and promotion rules set by Marketing and approved by the Tribal Gaming Agency (TGA) in determining the outcome.
- 5. Participants agree to the use of his or her name, city, state, and photograph for advertising and promotional purposes without charge or additional compensation.

## **Early Bird Drawings**

- 1. Starting at 8:00am on all valid Wednesdays all Sun Club Members age 55+ will earn one (1) drawing entry per one hundred (100) base points earned until 3:50pm.
- 2. All qualifying guests can track entries earned by swiping their Sun Club Membership Card at any Sun Club Kiosk any time after the start of the promotion.
- 3. All digital drawing tickets will be automatically added to qualifying participants' accounts during promotional timeframe.
- 4. A 4-digit pin set by each Sun Club member is required to access and track earned tickets progress under "Promotions" section at any kiosk.
- 5. All entry tickets will be placed into the digital drawing barrel and tracked via Atrient.
- 6. All participants must activate drawing tickets prior to the start of the drawings; Activation can be done starting at 11:00am on the valid promotional day by accessing promotion information at any kiosks in "STC".
- 7. The drawing barrel will be closing two (2) minutes prior to scheduled drawing time (11:58am, 12:28pm, 12:58pm, 1:28pm, 1:58pm, 2:28pm, 2:58pm, 3:28pm & 3:58pm). The purpose of closing the barrel prior to drawing time is for system processing.
- 8. One (1) winner will be drawn every 30 minutes beginning with the 12:00pm drawing through the 4:00pm drawing for a total of nine (9) winners each drawing day. A Sun Club Players Representative, TGA and person independent of the players club must be present at the drawing.
- 9. Each winner drawn will be displayed on TV screens throughout "STC" and announced via the overhead PA system; each winner will have five (5) minutes to

- show up to promotion table to claim their prize. STC is not responsible for PA malfunctions.
- 10. If the winner drawn does not show within given timeframe (5 minutes), that winner will be disqualified and a new winner will be drawn from the digital drawing drum.
- 11. Winners must be present to win; winners must have a valid photo ID and Sun Club Membership Card to claim their prize.
- 12. Each winner of the drawing will select a numbered prize card from the prize board. The number selected will be the winner's final prize. Prize cards contain cash amounts from \$100 to \$500 (See Prize Table for all amounts).
- 13. Prizes will be paid out at the Cage/Sun Club Desk; each winner will receive a payout slip provided by Marketing Promotion Staff and verified by a CSM after each drawing.
- 14. Each guest will only be able to win once per drawing day during the promotion.
- 15. The promotion/drawing will take place at designated areas on the casino floor of STC.

## **Swipe and Win Kiosk Game**

- 1. Eligible guest(s) can play up to one (1) swipe for free at any Sun Club Kiosk. Limit one swipe per player. Redemption period is 8am to 8pm. Guests can swipe their Sun Club Membership Card at any of the kiosks located in Spokane Tribe Casino to access the kiosk game.
- 2. Guest will be randomly assigned a "prize" (see prize detail below) by the kiosk after selecting the promotion icon (Icon for Senior Appreciation Day Swipe and Win) under "Promotions" section.
- 3. Winners must be present to win; prizes will be assigned at the time of participation.
- 4. The promotion will take place at all Sun Club Kiosks throughout Spokane Tribe Casino.
- 5. All participants must play their own promotion by using their own Sun Club Membership Card. No Substitutes are allowed.
- 6. Prizes will include Free Slot Play, Bonus Slot Points, and Cash. All prizes are non-transferrable.

### **General Rules:**

- 1. All use of "STC" stands for "Spokane Tribe Casino" All use of "TGA" stands for "Tribal Gaming Agency".
- 2. Must show your Sun Club card, proper ID, and be present to win.
- 3. It is the Sun Club member's sole responsibility to activate their Sun Club card into eligible gaming machines if participation is necessary to earn multiplier points.
- 4. All games/rule inquiries will be handled by the Marketing Department. Their decision/ruling on any matters within the promotion will be deemed final.
- 5. Drawing will be conducted by the standard operating procedures approved by TGA and/or the Spokane Tribal Gaming Commission.
- 6. The Spokane Tribe, any other sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use, or enjoyment of the prize(s), or damages or losses related to the promotion.
- 7. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes, unless expressly stated in the contest rules are not permitted, provided that, if the Tribe at its sole discretion reserves the right to substitute cash if a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
- 8. Winners will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 before a prize of \$600 cash or more will be awarded. Failure to provide required identification and complete required IRS Form W-9 will result in forfeiture of prizes.
- 9. Participants acknowledge that prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Spokane Tribe Casino will report winnings more than \$600 in

- cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
- 10. For promotions that require physical participation, selected participants who are physically unable to participate will be handled on a case-to-case basis by CSM and Marketing Management.
- 11. Participants are responsible for hearing promotion announcements and the Spokane Tribe Casino shall not be responsible in any manner for the failure of a participant to hear or respond to promotion announcements. If the promotion involves a drawing, in case of public address system failure the drawing may continue, and, in such event, the selected participant's name will be announced without amplification at the drawing location.
- 12. The Spokane Tribe Casino is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
- 13. The Spokane Tribe Casino is not responsible for inability to enter a promotion or a drawing due to long lines or other causes.
- 14. All employees of STC and Chewelah Casino are prohibited in participating in any casino promotions.
- 15. All relatives, spouse, partner, significant other or other individuals that may present a conflict of interest (those who share a financial responsibility with such as children, property, finances, etc.) of STC Marketing Team will not be allowed to participate in promotional events at the Spokane Tribe Casino.
- 16. Violation of promotion rules may result in disqualification.
- 17. Any participant dissatisfied with a decision/ruling in this promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Spokane Tribe Casino Gaming Commission.
- 18. Casino management and staff reserve the right to cancel or change any promotional event with proper notification to the public. Prior notification should include, but not be limited to, written notification within the gaming facility, publication in media venue or other methods as may be determined by management. It should also be known that cancellations or modification to any promotional event may be done at any time.
- 19. Management of STC, TGA and Spokane Tribal Gaming Commission reserves all other rights involved in any actions on STC property.
